### Fund Commentary

Stubborn US inflation again surprised the market on the upside and potential rate cuts by the Federal Reserve are being pushed out further, as the market acquaints itself with a "higher-for-longer" interest rate environment. Locally we have seen March headline inflation slowing with Namibia's print at 4.50% (February: 5.00%) and South Africa's print at 5.30% (February: 5.60%).

Long rates have strengthened throughout April. South African benchmark bond rates declining towards month-end with pre-election political risk fading on poll results, whilst Namibian spreads have contracted further, trading well below their South African counterparts, bolstered by the divergence of long-term economic sentiment between the two countries.

The fund continues to take advantage of attractive rates being offered in the South African sovereign and commercial banking sector.

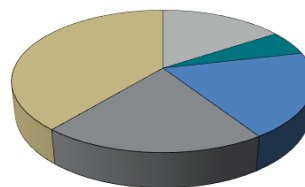
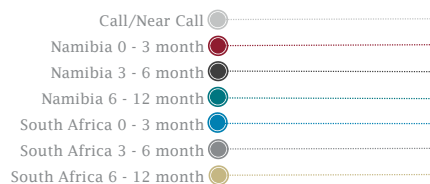
### Who Should Invest?

The Pointbreak Institutional Money Fund is suitable for investors seeking a low risk investment that maximises income. It offers a high income yield, capital stability and good liquidity.

### Investment Objective

The fund's objective is to achieve an investment return in excess of general money market instruments and funds, while ensuring a high degree of liquidity, capital preservation and below average risk. The fund invests with the four major banking groups in Namibia, the five major banking groups in South Africa, Nampost Namibia and the Namibian,- and South African Reserve Bank. Securities to be included in the portfolio consist of money market instruments, participatory interests in unit trust schemes, bank call and fixed deposits, fixed income securities, government bills and bonds, quality commercial paper and repurchase agreements.
