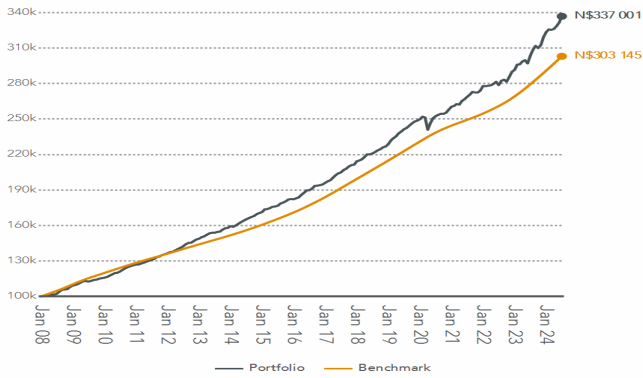

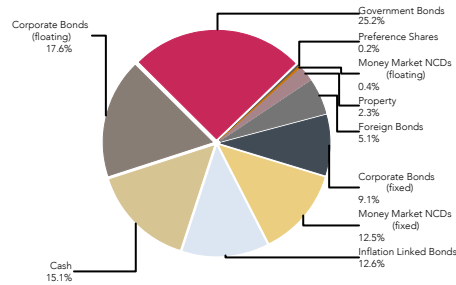

### Advice Costs
